2. Release the YMCA, it's directors, officers, employees, and volunteers (collectively "Releasees") from all liability to me for any loss or damage to property or injury or death to person, whether caused by Releasees or otherwise and while I am in or near the YMCA.
3. I agree not to sue Releasees for any loss, damage, injury or death described above and I will indemnify and hold harmless Releasees and each of them from any loss, liability, damage or cost they may incur due to my presence in, upon or near the YMCA branch; whether caused by the negligence of Releasees or otherwise.
4. I assume full responsibility for, and risk of, bodily injury, death or property damage due to the negligence of Releasees or otherwise.
5. The Richmond Family YMCA may use my photos for promotional purposes.

I intend this document to be as broad and inclusive as is permitted be the laws for the State of Indiana; if any portion hereof is held invalid, I agree the balance shall continue in full legal force and effect.

Code of Conduct and Participation Waiver/Release

Any person who supports the purpose and mission of the YMCA may become a member of the Richmond Family YMCA or may enroll as a participant or guest in accordance with such provisions as may be established from time to time by the Board of Directors, and shall have applicable privileges as a member, participant or guest unless the Richmond Family YMCA concludes, in its sole discretion, that a member has failed to live up to the standards and commitments of being associated with our YMCA.

By my signature below, I acknowledge the following:

a) Behavior and code of conduct agreement

The Richmond Family YMCA is founded on Christian principles and is committed to providing a safe and welcoming environment that is free of inappropriate behavior and unlawful conduct. This includes, but is not limited to, use of profanity or abusive language, fighting, inappropriate attire, theft or disrespect for property rights of the YMCA or others, unlawful possession, use, distribution or being under the influence of illicit substances and alcohol, smoking, conduct or actions of sexual nature, harassment or intimidation, carrying or concealing any weapons or objects which may be used as weapons, or criminal conduct of any type. The YMCA reviews sex offenders lists and reserves the right to do background checks.

The undersigned understands that such inappropriate behavior or conduct is unacceptable and the YMCA consequently retains the right to deny membership, program participation or access to services to its applicants and to revoke a membership of any current member, participant or guest at its sole discretion if:

- i) It appears that you are acting in a way that is contrary to the YMCA's mission and values, or
- ii) It appears that you are involved in criminal activity, or
- iii) Acting in ways that disrupt the YMCA's operation.

b) Release and Waiver

In consideration of being permitted to enter into or upon or to utilize the facilities, services, and programs of the YMCA, or the use thereof of participation therein by any child or children of mine, for any purpose whatsoever, including, without limitation, the participation, as a spectator or participant in any on-site program, or the use of facilities or equipment, owned, operated or affiliated in any manner with the YMCA, do for myself, my heirs, assigns and personal representative, hereby and with these forever release, waive, acquit and discharge and agree to hold strictly harmless the YMCA, its directors, agents, servants and employees, from and against any and all actions, causes of actions, claims, damages, suits, demands, expenses, and liability arising out of or claimed to have been incurred or sustained by the undersigned, or to or by any child or children of the undersigned, while the undersigned or such child is in, at, upon or about the premises or while engaged in any activity within any of the facilities, or participating in any program, or using any equipment, owned operated, maintained, or affiliated with the YMCA.
